

WAIVER AND RELEASE OF CLAIMS

PLEASE READ CAREFULLY – THIS IS A RELEASE OF LIABILITY AND A WAIVER OF CERTAIN LEGAL RIGHTS

By registering for and attending the AVMA Convention, you, on behalf of yourself and your guests (including, without limitation, family members) (“Guests”), assume all risks associated with your attendance and participation in all on- and off-site activities that are part of or affiliated with the AVMA Convention. By registering for this meeting, you, on behalf of yourself and your Guests, agree to indemnify, defend, and hold harmless the AVMA, its officers, directors, employees, and agents from all loss, damages, costs, expenses (including reasonable attorney’s fees) or liability arising out of or related to attendance and participation at the AVMA Convention by you and your Guests, including without limitation, personal injury (including death) or any damage caused by you or any of your guests to any venue utilized by AVMA for the Convention, or your failure to comply with applicable law or the rules and regulations of the host venue or other venues utilized.

TO THE FULLEST EXTENT PERMITTED BY LAW, I, ON BEHALF OF MYSELF AND MY GUESTS, DO HEREBY RELEASE, ACQUIT AND FOREVER DISCHARGE THE AMERICAN VETERINARY MEDICAL ASSOCIATION, ITS OFFICERS, DIRECTORS, EMPLOYEES, INSURERS AND AGENTS OF AND FROM ANY AND ALL, AND ALL MANNER OF CHARGES, CLAIMS, ACTIONS, RIGHTS, DEMANDS, DEBTS, LIABILITY, ACTIONS, CLAIMS FOR ATTORNEYS’ FEES DAMAGES OF ANY KIND AND NATURE WHATSOEVER, IN LAW OR EQUITY, INCLUDING BUT NOT LIMITED TO CLAIMS FOR PROPERTY DAMAGE AND/OR BODILY INJURY, RIGHTS RELATED TO PRIVACY OR MISAPPROPRIATION OF IMAGE OR LIKENESS, EVEN IF CAUSED BY NEGLIGENCE OR GROSS NEGLIGENCE, ARISING OUT OF THE ACTS OF THE AMERICAN VETERINARY MEDICAL ASSOCIATION, ITS AGENTS, OFFICERS, CONTRACTORS OR EMPLOYEES THAT MAY ARISE OR OCCUR IN CONNECTION WITH OR AS A RESULT OF ATTENDING THE AVMA CONVENTION.

Photograph/Video/Recording Release

AVMA has photographers/videographers that are authorized by AVMA to take photos, videos, or make other recordings (“Recordings”) of attendees at Convention events, or of people participating in functions or activities related to the Convention. AVMA may use the Recordings in the future for any purpose, including without limitation, commercial, marketing, publicity, promotions, advertising, educational, or other purposes. By registering for the Convention, you, on behalf of yourself and your Guests, expressly consent and agree to allow AVMA to make and use the Recordings, which may include you, your family members or other Guests (including individuals under the age of 18), in all media formats worldwide for whatever purposes AVMA deems appropriate. You acknowledge and agree that AVMA shall own all intellectual property rights, if any, arising in connection with the Recordings, and that neither yourself nor your Guests or children shall receive (or be entitled to receive) any royalties or other compensation from AVMA for any use of the Recordings.
