REVISED POLICY ON TRANSPORTATION OF RESEARCH ANIMALS FOR THE PURPOSE OF RESEARCH, TESTING, AND EDUCATION

RESOLVED, that the American Veterinary Medical Association (AVMA) House of Delegates (HOD) adopt the revised policy on Transportation of Research Animals for the Purpose of Research, Testing, and Education as noted below (additions are <u>underlined</u>; deletions are <u>struckthrough</u>).

Transportation of research animals for the purpose of biomedical research, testing, and education

The AVMA supports the transportation of animals for research, testing, and education when that transportation is conducted in accord with regulations and guidelines that assure animals are handled appropriately per age and species needs and transport is conducted humanely. This transportation of research animals refers to any movement of all animals intended for use in biomedical research, testing, and/or education from one facility (dedicated breeding or research) to another. This includes purpose-bred animals, legally obtained random-source animals, hoof stock, and genetically altered (e.g., transgenic and knock-out) animals. The AVMA supports the transportation of animals for research, testing and education when that transportation is conducted in accord with guidelines that assure animals are handled properly and transport is conducted humanely. Those handling the animals during transport must be well trained and competent in performing tasks and making related decisions related to the welfare of the animal(s) during the transport.

Veterinarians are responsible for ensuring the appropriate transportation of animals for research, testing, and education, and therefore should be involved in the evaluation of specific transportation methods. Both air and ground transportation methods should be available in order to select the method(s) that provide the highest degree of animal welfare protection, taking into consideration the animal species and particular transportation situation.

Statement about the Resolution

The Animal Welfare Committee (AWC) reviewed this policy in accordance with the every-fiveyear review directive. The current revision proposed eliminates unnecessary repetition while also clarifying the intent. A statement regarding the AVMA stance on transportation of research animals for research, testing and education was moved from the body of the policy to the first sentence.

Additional language was added as recommended by the American Society of Laboratory Animal Practitioners to address the veterinarian's role in these transportation situations in order to protect animal welfare.
