




1. North Pole is free of foot-and-mouth disease, rinderpest, contagious pleuropneumonia, and surra.
2. Continuous records (from the time of birth until export) of animal identification and herds of residence of the animals being exported were verified on the export health certificate by the issuing accredited veterinarian.
3. The herd is enrolled in the North Pole CWD Voluntary Herd Certification Program and has achieved Fully Certified status.
4. CWD has never been diagnosed in the enrolled herd or the herd of origin.
5. The herd of origin is a herd officially recognized as free of TB and brucellosis according to the provisions of the North Pole captive ungulate program, and there has been no direct or indirect contact between the herd of origin and any known TB and brucellosis infected source.
6. The herd of origin is not known to have been exposed to any wild population infected with TB, brucellosis, or CWD.
7. The herd of origin does not contain animals from any herd where TB or brucellosis has ever been diagnosed.
8. Neither TB nor brucellosis has been diagnosed on the premises of origin during the five (5) years preceding the start of testing for export.
9. On the premises of origin, all TB or brucellosis susceptible ruminants have either attained the status of a herd officially recognized free by the North Pole of TB and brucellosis; or are from a herd of negative status for TB and brucellosis under the North Pole Program for Farmed Cervids.
